BACKGROUND/EVALUATION

This solicitation was advertised for professional engineering services to provide engineering for site development, specifications and engineering calculations, structural analysis, system evaluation, system recommendation and preparation of project schedules throughout the County. Additional services needed for surveying, value engineering, cost estimating, investigation of existing mechanical, electrical, and plumbing systems, and development of rehabilitation plans for existing systems, energy, and environmental consulting services, prepare energy documents, fire protection, and life safety system engineering.
