SECTION A: INFORMATION TO PROPOSERS

PROPOSERS MUST COMPLY WITH THE FOLLOWING INSTRUCTIONS TO BE CONSIDERED FOR SELECTION.

A.01 OPENING LOCATION

These proposals will be <u>publicly opened</u> at Manatee County Purchasing Division, 1112 Manatee Avenue West, 8th Floor, Suite 803, Bradenton, Florida 34205, in the presence of County officials at the time and date stated on the cover sheet. All Proposers or their representatives are invited to attend.

A.02 PROPOSAL INFORMATION AND PROPOSAL DOCUMENTS

Request For Proposal documents and the Notices of Intent to Award related to those Proposals are available for download in a portable document format (.PDF) file on the Manatee County web page on the Purchasing tab under "Bids and Proposals". You may access these files using Adobe Acrobat software. You may download a free copy of this software (Adobe) from the County's web page if you do not have.

IT IS THE RESPONSIBILITY OF EACH PROPOSER, PRIOR TO SUBMITTING THEIR PROPOSAL, TO CONTACT THE MANATEE COUNTY PURCHASING DIVISION (see contact information on page one of this document) TO DETERMINE IF ADDENDA WERE ISSUED AND TO MAKE SUCH ADDENDA A PART OF THEIR PROPOSAL.

A.03 REQUIREMENTS FOR FORMAT AND DELIVERY OF PROPOSALS

Any proposals received after the stated time and date will not be considered. It shall be the sole responsibility of the Proposer to have their proposal delivered to the Manatee County Purchasing Division for receipt on or before the stated time and date. If a proposal is sent by U.S. Mail, the Proposer shall be responsible for its timely delivery to the Purchasing Division. Proposals delayed by mail shall not

be considered, shall not be opened at the public opening, and arrangements shall be made for their return at the Proposer's request and expense.

Proposals must be submitted in the format specified in Section C hereof. The contents of each proposal shall be **separated and arranged with tabs in the same order as listed in the Subsections within Section C** identifying the response to each specific item thereby facilitating expedient review of all responses.

A.04 CLARIFICATION & ADDENDA

Each Proposer shall examine all Request for Proposal documents and shall judge all matters relating to the adequacy and accuracy of such documents. Any inquiries, suggestions or requests concerning interpretation, clarification or additional information pertaining to the Request for Proposal shall be made in writing through the Manatee County Purchasing Division. The County shall not be responsible for oral interpretations given by any County employee, representative, or agent. The issuance of a written addendum by the Purchasing Division is the only official method whereby interpretation, clarification or additional information can be given.

A.05 SEALED & MARKED

Manatee County requires a total of seven copies of your proposal to be submitted in <u>one</u> sealed package. The contents of your sealed package shall include: **One signed Original (marked Original) and Five (5) Copies (each marked Copy) and One (1) Electronic copy.** The electronic copy shall be in a pdf format and submitted on a CD or USB flash drive which is non-returnable. *All seven copies of your proposal shall be identical.*

A.06 LEGAL NAME

Proposals shall clearly indicate the legal name, address and telephone number of the Proposer (company, firm, partnership, individual). Proposals shall be signed above the typed or printed name and title of the signer. The signer shall have the authority to bind the Proposer to the submitted proposal.

A.07 PROPOSAL EXPENSES

All expenses for making proposals to the County are to be borne by the Proposer.

A.08 EXAMINATION OF OFFER

The examination of the proposal and the Proposer generally requires a period of not less than ninety (90) calendar days from the date of the opening of the proposals.

A.09 DISCLOSURE

Upon receipt, all inquiries and responses to inquiries related to this Request for Proposal become "Public Records" and are subject to public disclosure consistent with Chapter 119, Florida Statutes.

Proposals become subject to disclosure thirty (30) days after the Opening or if a notice of intended award decision is made earlier than this time as provided by Florida Statute 119.071(1)(b). No announcement of review of the offer shall be conducted at the public opening. If the County rejects all offers and concurrently notices its intent to reissue the solicitation, initial offers are exempt until the County provides notice of its intended decision or, thirty (30) days after the opening of the new offers.

Pursuant to Florida Statutes 119.0701, to the extent successful Proposer is performing services on behalf of the County, successful Proposer must:

- a. Keep and maintain public records that ordinarily and necessarily would be required by the County in order to perform the service;
- b. Provide the public with access to public records on the same terms and conditions that the County would provide and at a cost that does not exceed the cost provided in F.S. Chapter 119, or as otherwise provided by law;

- Ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law, and;
- d. Meet all requirements for retaining public records and transfer, at no cost, to the County all public records in possession of successful Proposer upon termination of the awarded Agreement and/or PO and destroy any duplicate public records that are exempt or confidential from public records disclosure requirements. All records stored electronically must be provided to the County in a format this is compatible with the County's information technology systems.

A.10 ERRORS OR OMISSIONS

Once a proposal is submitted, the County shall not accept any request by any Proposer to correct errors or omissions in the proposal.

A.11 DISQUALIFICATION DUE TO NON-RESPONSIVENESS

Manatee County reserves the right to find that any proposal received which does not contain all of the information, attachments, verification, forms or other information, may be considered non-responsive and therefore be disqualified from eligibility to proceed further in the RFP process.

A.12 RESERVED RIGHTS

The County reserves the right to accept or reject any and/or all proposals, to waive irregularities and technicalities, and to request resubmission. Any sole response received by the first submission date may or may not be rejected by the County, depending on available competition and timely needs of the County. The County reserves the right to award the contract to a responsible Proposer submitting a responsive proposal, with a resulting negotiated agreement which is most advantageous and in the best interests of the County. The County shall be the sole judge of the proposal, and the resulting negotiated agreement that is in its best interest and its decision shall be final. Also, the County reserves the right to make such investigation as it deems necessary to determine the ability of any Proposer to perform the work or service requested. Information the County deems necessary to make this determination shall be provided by the Proposer. Such information may include, but shall not be limited to: current financial statements prepared by an independent CPA; verification of availability of equipment and personnel; and past performance records.

A.13 APPLICABLE LAWS

Proposer must be authorized to transact business in the State of Florida. All applicable laws and regulations of the State of Florida and ordinances and regulations of Manatee County will apply to any resulting agreement. Any involvement with any Manatee County procurement shall be in accordance with Manatee County Code Chapter 2-26.

A.14 CODE OF ETHICS

With respect to this proposal, if any Proposer violates, directly or indirectly, the ethics provisions of the Manatee County Purchasing Code and/or Florida criminal or civil laws related to public procurement, including but not limited to Florida Statutes Chapter 112, Part II, Code of Ethics for Public Officers and Employees, such Proposer will be disqualified from eligibility to perform the work described in this Request for Proposal, and may also be disqualified from furnishing future goods or services to, and from submitting any future bids or proposals to supply goods or services to, Manatee County.

By submitting a proposal, the Proposer represents to the County that all statements made and materials submitted are truthful, with no relevant facts withheld. If a Proposer is determined to have been untruthful in its proposal or any related presentation, such Proposer will be disqualified from eligibility to perform the work described in this Request for Proposal, and may also be disqualified from furnishing future goods or services to, and from submitting any future bids or proposals to supply goods or services to, Manatee County.

A.15 COLLUSION

By offering a submission to this Request for Proposal the Proposer certifies the Proposer has not divulged to, discussed or compared his proposal with other Proposers and has not colluded with any other Proposer or parties to this proposal whatsoever. Also, the Proposer certifies, and in the case of a joint proposal, each party thereto certifies, as to their own organization that in connection with this proposal:

- any prices and/or data submitted have been arrived at independently, without consultation, communication or agreement, for the purpose of restricting competition, as to any matter relating to such prices and/or cost data, with any other Proposer or with any competitor;
- any prices and/or cost data quoted for this proposal have not been knowingly disclosed by the Proposer prior to the scheduled opening directly or indirectly to any competitor;
- no attempt has been made or will be made by the Proposer to induce any other person or firm to submit or not to submit a proposal for the purpose of restricting competition;
- d. the only person or persons interested in this proposal as principal or principals is/are named therein and that no person other than therein mentioned has any interest in this proposal or in the contract to be entered into; and

e. no person or agency has been employed or retained to solicit or secure this contract upon an agreement or understanding for a commission, percentage, brokerage, or contingent fee, excepting bona fide employees.

A.16 PUBLIC ENTITY CRIMES

In accordance with Section 287.133, Florida Statutes, a person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a proposal on a contract to provide any goods or services to a public entity, may not submit a proposal on a contract with a public entity for the construction or repair of a public building or public work, may not submit proposals on leases or real property to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017 for Category Two for a period of 36 months from the date of being placed on the convicted vendor list.

In addition, Manatee Code of Laws Chapter 2-26 Article V prohibits the award of County contracts to any person or entity who/which has, within the past 5 years, been convicted of, or admitted to in court or sworn to under oath, a public entity crime or of any environmental law that, in the reasonable opinion of the Purchasing Official, establishes reasonable grounds to believe the person or business entity will not conduct business in a reasonable manner.

To ensure compliance with the foregoing, the Code requires all persons or entities desiring to contract with the County to execute and file with the purchasing official an affidavit, executed under the pain and penalties of perjury, confirming that person, entity, and any person(s) affiliated with the entity, does not have such a record and is therefore eligible to seek and be awarded business with the County. **Proposer is to complete Attachment "B" and submit with your proposal.**

A.17 LOBBYING

After the issuance of any Request for Proposal, prospective Proposers, or any agent, representative or person acting at the request of such Proposer shall not contact, communicate with or discuss any matter relating in any way to the Request for Proposal with any officer, agent or employee of Manatee County other than the Purchasing Official or as directed in the Request for Proposal. This prohibition includes the act of carbon copying officers, agents or employees of Manatee County on email correspondence. This requirement begins with the issuance of a Request for Proposal, and ends upon execution of the final Contract or when the Proposal has been canceled. Violators of this prohibition shall be subject to sanctions as provided in the Manatee County Purchasing Code of Law Chapter 2-26.

A.18 EQUAL EMPLOYMENT OPPORTUNITY

In accordance with the provisions of Title VI of the Civil Rights Act of 1964 and Title 15, Part 8 of the Code of Federal Regulations, Manatee County hereby

notifies all prospective Proposers that they will affirmatively ensure minority business enterprises will be afforded full opportunity to participate in response to this advertisement and will not be discriminated against on the grounds of race, color or national origin in consideration for an award of contract.

A.19 AMERICANS WITH DISABILITIES ACT

The Board of County Commissioners of Manatee County, Florida, does not discriminate upon the basis of any individual's disability status. This non-discrimination policy involves every aspect of the County's functions including one's access to, participation, employment, or treatment in its programs or activities. SECTION B: SCOPE OF SERVICES

B.01 BACKGROUND AND INTRODUCTION

Manatee County is a growing Florida county located on the southwest coast and consists of 15 miles of coastline on the Gulf of Mexico and 743 square miles of land. Manatee County is home to over 353,000 residents and attracts more than 2.8 million visitors each year. Visitation has been steadily increasing at nearly 4% per year to the area.

The preserve at Jigg's Landing is located in the thriving east side of the County, just west of Interstate 75 off Caruso Road. The site address is 6106 63rd Street East, Bradenton. Jigg's Landing is located on the Ever's Reservoir and the Braden River offering many outdoor recreational activities including freshwater fishing, picnicking and canoeing.

Jigg's Landing was extensively renovated in 2010 and is well known for its 24 hour accessible boat ramp allowing boaters to launch directly into the Braden River. The renovations include the following amenities:

- Picnic pavilions
- Boardwalks
- Concession Stand
- Cooking Grilles
- Wildlife viewing areas
- Dock
- Nature-Themed playground
- ADA accessible canoe/kayak launch
- Boat ramp with Boat trailer parking lot
- Small historic cabin representation
- Shower house with rest rooms

Manatee County anticipates awarding an initial two (2) year agreement for the concession at Jigg's Landing to provide services and operations in an effort to promote a positive recreational experience with possible renewals.

B.02 SCOPE OF SERVICES

General Operating Requirements:

- Operate the concession to the benefit of the general public beginning within thirty (30) days from the date of executed contract including but not limited to cabin rentals, kayak/canoe rentals, small motor boat rental, bait & tackle sales, sundry and snack shop.
- Concessions must be operated at a minimum of four (4) days per week.
 Operating hours to be negotiated. The minimum days of operation are Thursday through Sunday. Additional days may be added as operations expand.

- The County reserves the right to offer tours and hold special events at the park. These tours or events will be coordinated with the selected Proposer to minimize any impact on their operation.
- Maintain all areas on grounds as specifically negotiated. Maintain restrooms and showers. Nightly disposal of all trash and litter, clean and maintain all grills on an as needed basis and clean and/or maintain all other equipment, not listed, as required. Selected Proposer will need to purchase and provide own cleaning equipment, supplies and materials.
- The selected Proposer shall perform all work without the use of subcontractors, unless written permission is received and approved by the County. A Subcontractor shall be considered any individual, partnership or corporation supplying materials or services for work under subcontract to the selected Proposer. The County may ask subcontractors to provide appropriate experience, references, and insurance. The County reserves the right to refuse any proposed subcontractors.
- Any website and social networking sites created by and operated by the selected Proposer referencing the operations at Jigg's Landing shall be monitored and approved by the County for content prior to use.
- The selected Proposer must, as a representative of the County, conduct operations in a professional manner at all times.
- All charges for utilities applicable and specifically measured will be the responsibility of the selected Proposer.
- The selected Proposer shall not erect or post signs, banners, and promotional material without the prior written approval of the County. Permits may be required for such activities. Obtaining of all permits shall be the responsibility of the selected Proposer.
- All advertising, marketing and signage shall be the responsibility and expense of the selected Proposer.
- The selected Proposer is required to maintain the prescribed level of insurance at all times throughout the term of the agreement and any subsequent renewals.
- The selected Proposer shall provide a Point of Sale (POS) System for the operation.
- Any County-provided equipment as well as any selected Proposer-installed permanent fixtures will become the property of the County at expiration and/or termination of the Agreement.
- The selected Proposer will have access to the parking currently available on the premises in designated areas.

Staffing Requirements:

- The selected Proposer shall select, employ, and train personnel, who shall, at all times, conduct themselves in a professional and courteous manner.
- Staff of the selected Proposer shall be recognizable to the general public. All uniforms shall be approved by the County prior to operation of the concession.
- The selected Proposer shall be responsible for the discipline and, if necessary, discharge of any and all personnel working in this operation.
- The amount of staff must be able to meet the needs of the public.

• The County reserves the right to perform background checks on the selected Proposer and the staff at its sole discretion.

Concession Requirements:

- The selected Proposer shall operate a concession offering the following amenities to the public:
 - Coordination of rental of cabins located on the site (rates set by the County)
 - Kayak/Canoe/Paddleboard rentals (rates approved by the County)
 - > Sale of bait and tackle
 - > Sale of sundry items
 - Sale of pre-packaged food items
 - Coordinate and service County lease kayak storage bins (when/if available and rates are to be set by the County)
 - Operate a seasonal tour boat (optional)
 - > Small motor boat rentals-5 HP outboard motors (optional)
- The County reserves the right to expand the scope of services with the mutual agreement of the selected Proposer.
- Application for permission to sell beer and wine may be considered at a later date with the approval of the Board of County Commissioners.
- All products and services offered shall be of excellent quality and adequate quantity and offered at reasonable prices.
- All proposed products, services and pricing shall be reviewed and approved by the County. Any product and price changes must be submitted in writing to the County for review and approval.

Watercraft Safety Requirements:

- The selected Proposer shall be required to rent kayaks/canoes, paddles and personal floatation devices (PFDs) to the public. Equipment shall only be rented to individuals at least 21 years of age. In addition, the selected Proposer may provide pontoon boat ride tours. Children under the age of 18 years are required to wear a PFD at all times.
- All services shall be performed in accordance with applicable federal, state and local regulations, statutes, and ordinances, including provisions for all safety related equipment as required and approved by the U.S. Coast Guard.
- The selected Proposer shall be fully responsible for obtaining all required licenses and permits.
- Keeping renters safe while engaged in activities relating to this business will be of the highest priority. The selected Proposer shall take the necessary safety precautions to ensure that the public and environment are protected. The selected Proposer will have at a minimum, one staff on duty, at all times, with CPR and First Aid certification. A medical kit is to be on premises at all times and shall be inventoried and replenished accordingly on a regular basis to ensure adequate stock is on hand at all times. A CPR certified staff member will be deployed in instances where a patron is too sick to paddle, injured, or

- otherwise debilitated while operating the rented equipment. A retrieval boat with a motor must be available at the site at all times.
- The selected Proposer shall report of all accidents or incidents to the County immediately after occurrence.
- Manatee County requires that the selected Proposer close the selected Proposer's operation whenever severe storms or other climatic, health or structural related hazards make human health or safety a concern. If the closure is for an extended period of time, the parties may negotiate a pro-rated reduction in the rental payment due to the County.
- The selected Proposer shall provide each patron with a detailed rental agreement, approved by the County. The rental agreement shall be signed by prior to commencement of services. All signed rental agreements must be kept on file.
- Instruction or education in equipment operation as well as waterway rules and regulations must be provided to patrons at the time of rental.
- The selected Proposer shall be responsible for all maintenance and repair of all rental equipment; and shall not rent any equipment that is damaged, in need of repair, or compromised in any way.
- All rental equipment used shall be marked with the name or logo of the selected Proposer. The markings shall be plainly visible and legible.
- The selected Proposer shall be responsible for transportation, setup, assembly, and securing all rental and related equipment. All rented watercraft are to be portaged in and out of the launch area and removed from the facility daily. No equipment, supplies or any other related items shall be left in the water, parking lot, or any other area of the facility overnight.

Audit and Site Visit Requirements:

- The selected Proposer must maintain proper financial records and provide full access to County upon request. The County will provide the selected Proposer with a minimum of ten (10) business day notice prior to any audit conducted by the County. The selected Proposer is required to maintain, at its sole expense, accurate financial records including but not limited to:
 - > Revenue and expense reports
 - ➢ Florida State Sales Tax returns
 - > Federal Payroll Tax returns
 - Any recorded ledgers
 - Personnel records
 - > Contracts with sub-contractors and suppliers
- The selected Proposer shall submit monthly revenue reports, quarterly balance sheets and annual accounting.
- The selected Proposer shall provide the County with copies of the Florida State Sales Tax returns and Federal Payroll returns accompanied by evidence of payment.

County Contributions:

- The County will maintain the docks, boat ramp and the exterior of the buildings in good working order. Daily maintenance will be the responsibility of the selected Proposer.
- The County may purchase and install certain equipment for the development of a completely operational "fish camp and outfitter" store.
- Provide initial furnishings for the rental cabins.
- The County is willing to consider waiving a portion of the compensation to the County for up to the first twelve (12) months of the Agreement. The selected Proposer will be required to provide the County with a percentage of revenue from the rental of the cabins for maintenance. Percentage of revenue to be determined by the County.

SECTION C: FORM OF PROPOSAL

This section identifies specific information which must be contained within each proposal. The contents of each proposal shall be <u>separated</u> and <u>arranged with tabs</u> in the same order as listed in <u>Sections C.01</u>, <u>through C.03</u>, identifying the response to each specific item.

The information that you provide shall be used to determine those Proposers with perceived ability to perform the Scope of Services as stated in this Request for Proposal which may overall best meet the needs of Manatee County. A review with those Proposers reasonably susceptible of being selected for award may be conducted for the purposes of clarification of both ability and benefit to Manatee County. See Section D. Selection.

C.01 MINIMUM QUALIFICATIONS (Licensing) TO BE CONSIDERED

To qualify for any consideration, the Proposer(s) must present proof of ability to meet the requirements for any licensing or certification which will be required by law to perform the services set out in the scope of services required in this RFP.

Proposals may be presented by a single business entity, individual, a joint venture, or partnership.

Prior to any consideration of the responses to the criteria in this Request for Proposal, Proposers are to document in their Proposals that they have the following experience:

MINIMUM EXPERIENCE TO BE CONSIDERED

Proposers shall have substantial, current and verifiable experience in performing or overseeing the performance of the services described within the scope of services set forth herein. In the event more than one entity is joining in making this proposal, each entity shall set forth its respective experience and qualifications for those areas the entity intends to perform.

If subcontractors are to be used in your proposal given to meet the minimum qualifications detail the business entities, description of the service provided, and responses in the same level of detail and tabbed order as instructed in this Request for Proposal for the Proposer.

The amounts and types of insurance coverage shall conform to the minimum requirements set forth in this Exhibit, with the use of Insurance Services Office (ISO) forms and endorsements or their equivalents. By submitting a bid to this IFB, the bidder agrees should the bidder's bid be accepted, to execute the form of Agreement and present the same to Manatee County for approval within ten (10) calendar days after notice of intent to award. The bidder further agrees that failure to execute and deliver said form of Agreement within ten (10) calendar days will result in damages to Manatee County and as guarantee of payment of same a bid bond/certified check shall be enclosed within the submitted sealed bid in the amount of five (5%) percent of the total amount of the bid. In addition, pursuant to Section 255.05(1)(b), Florida Statutes, prior to commencing Work, the successful bidder shall be responsible and bear all costs associated to record the Payment and Performance Bond with the Manatee County Clerk of the Circuit Court. A certified copy of said recording shall be furnished to the Purchasing Division upon filing. Pursuant to Section 255.05(1)(b), Florida Statutes, Owner will make no payment to the successful bidder until the successful bidder has complied with this paragraph.

Furnishing Payment and Performance Bonds shall be requisite to execution of an Agreement with Owner. Said Payment and Performance Bonds will remain in force for the duration of the Agreement with the premiums paid by the successful bidder. Failure of the successful bidder to execute such Agreement and to supply the required bonds shall be just cause for cancellation of the award. Owner may then contract with the next lowest, responsive and responsible bidder or re-advertise this IFB. If another bidder is accepted, and notice given within ninety (90) days after the opening of the bids, this Acceptance shall bind the bidder as though they were originally the successful bidder.

Failure of Owner at any time to require performance by the successful bidder of any provisions set out in the resulting Agreement will in no way affect the right of Owner, thereafter, to enforce those provisions.
