Authorization to award IFB 15-1058-DS, Southeast Water Reclamation Facility (SEWRF) Septage / Grease Receiving Station Project to the lowest, responsive, and responsible bidder, Vogel Bros. Building Co., Lakeland FL, for a total of \$3,586,000.00 with 360 calendar days for completion; and authorize the County Administrator, or designee, to execute the Agreement and accept and date the public construction bond.

#### **Background Discussion**

The Work included in the contract consist of furnishing, delivering and installing all materials, equipment, incidentals and services, including labor for the construction of the Manatee County Southeast Water Reclamation Septage/Grease Receiving Station located at 3331 Lena Road in Bradenton, Florida.

The work generally includes, but is not necessarily limited to:

1. Excavation, compaction, demolition, clearing and grubbing, and earthwork at the location of the proposed Work.

2. Construction of cast-in place concrete and asphalt pavement.

3. Construction of stormwater facilities including a stormwater drainage retention pond.

4. Above ground grease storage tank and an above ground septage storage tank.

5. Construction of grease and septage receiving stations including all associated processing equipment, pumping stations, electrical work, and yard piping.

During construction, provisions shall be made to allow continuous operation of the existing treatment facility at all times.
