NOTICE OF INTENT TO AWARD

Noncompetitive notice of Intent to Award Task #20170133 for the procurement of Computerized Chemicals and Maintenance of Water Management Programs for GT Bray Aquatics, John Marble, East Bradenton and Pride Park to Poolsure located in Houston, Texas.

BACKGROUND/DISCUSSION

- This procurement is for a computerized/automated chemical and maintenance water management program. Included in the automated program are the chemicals, chemical controllers, and chemical pumps. Poolsure provides and monitors all chemical levels and adjusts levels as required via wireless telemetry as well as maintaining all controllers and pumps.
- Poolsure is the only known company that provides this full service water management program.
- Locations include:
 - East Bradenton - three (3) bodies of water
 - GT Bray Recreation Center - three (3) bodies of water
 - John Marble
 - Pride Park
- Program provides a safer environment for County employees that no longer need to transport / monitor / handle / dispense hazardous chemicals on a daily basis.
- The annual estimated expenditure is \$60,600.00.
