RFO 22-R078750AJ is amended as set forth herein. Responses to questions posed by prospective bidders are provided below. This Addendum is hereby incorporated in and made a part of RFO 22-R078750AJ.

The deadline to submit all inquiries concerning interpretation, clarification or additional information pertaining to this RFO was April 21, 2022.

QUESTIONS AND RESPONSES:

- Q1. Is a bid bond required with submission of the qualification package?**
R1. There is not a bid bond requirement for this solicitation.
- Q2. Is a payment and performance bond going to be required?**
R2. A payment and performance bond will not be required for this solicitation.
- Q3. Is a Geotech report available for review? If not, should we anticipate that a dewatering system be installed prior to draining the pool?**
R3. There is no Geotech report available. A dewatering system in conjunction with draining the pool may be needed.
- Q4. The amount of delaminated material from the surface of the pool that will need to be removed is unknown. Will the County provide a quantity in the base bid that we should include? A separate square foot price can also be included on the bid sheet should the material removal requirement found be in excess of that amount.**
R4. Offeror will use their expertise and standards in determining a reasonable amount of delamination in the offer.

- Q5. Section 1.04 I – states to provide tile trim around main drains and inlets in pool. This isn't typically done, is this a requirement?**
- R5. Tile will need to be replaced where tile is already located. If there happens to be a drain positioned on a tiled lap lane, then the tile will need to be properly installed around the drain.
- Q6. Section 1.04 Q a & b – please clarify if new handrails and ladders are required for this project?**
- R6. If Offeror determines that ladders and handrails should be replaced, please include it within the offer. Also, if they are replaced, please include all parts of the ladders and handrails.
- Q7. Is the County paying for the water and chemicals to refill the pool?**
- R7. The County will continue to maintain the water bill and the chemicals for the pool. If additional chemicals are suggested for this project, please advise in offer.
