Bidders are hereby notified that this Addendum shall be acknowledged on Bid Form Page 00300-1 of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without Acknowledgement of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding document, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

The deadline of April 8, 2016 to submit all inquiries concerning interpretation, clarification or additional information pertaining to this bid has lapsed. This deadline has been established to maintain fair treatment for all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve.

## <u>Bidders Note 1:</u> - <u>General Information.</u> The Engineer of Record has provided additional information for clarification purposes:

- The Central Library has various IT rooms. In order to determine which IT room within the Central Library the CAT6 Cabling is to be connected, the successful bidder shall coordinate with Owner and Manatee County IT personnel.
  - Lump Sum pricing for bid item # 4, Lighting, Luminaires, Wiring and Power Devices shall include 300 ft. of plenum rated cabling (CAT6), 295ft of ¾" conduit and strapping, two (2) junction boxes, and a connection (RJ-45 per the Stick-GA2 requirements) for the IT run. Revised Measurement and Payment Section for bid item #4 is made a part of this Addendum #1. (1 total page)
- 2. Means and methods are done by the contractor. The connection of multiple lights/luminaries may be done via a daisy chain provided the daisy chain conduit is slightly hidden (directly against the wall under the roof). The lighting should be mounted beneath the roof structure and any penetrations should be coordinated with the roof manufacturer. County Representative shall provide roof manufacturer's contact information should the need arise.

## Bidders Note 2: - Clarification of Bid

**Bid A (1):** Exterior /Façade Lighting: See Sheet E2.0, details 1/E4.0, 2/E4.0, 3/E4.0. The balcony and loading dock area are part of Bid B (2). The L3 / L4 fixtures have already been replaced and shall not be included in the job. The Plan Sheets have been updated to reflect this change.

**Bid B (2):** The entire project is included on Plan Sheets E2.0 and E2.1. The L3 / L4 fixtures have already been replaced and shall not be included in the project. Revised Plans are made a part of this Addendum #1. (8 total pages)

Revised Bid Forms for Bid "A" and Bid "B" which are made a part of Addendum #1 shall be utilized. (7 total pages)

## **Bidders Note 3:**

A copy of the Non-Mandatory Information Conference Attendance Record and Site Inspection Attendance Record which was held on March 31, 2016 is made a part of this Addendum #1. (2 total pages)

## **Bidders Note 4:**

Reply to questions received at the Pre-Bid Conference held on March 31, 2016 and emailed to the Purchasing Division through April 8, 2016:

- Q1. Per Sheet E1.0: Confirm that MC Cable is not going to be allowed for this project.
- A1. No MC Cable is required for this project.
- Q2. Per Sheet E2.0: The existing L3 / L4 fixtures appear to be new LED fixtures? Please confirm.
- A2. The existing fixtures L3 / L4 are new and will not be required to be supplied. Reference revised Plan Sheet E2.0 which is made a part of this Addendum #1.
- Q3. Per Sheet E2.0: Where is the location of the IT Room?
- A3. See <u>Bidders Note 1</u>, additional <u>General Information</u> provided by the Engineer of Record.
- Q4. Per Sheet E2.0: What size conduit is required from the color controller to the IT Room?
- **A4.** The conduit size for the controller shall be 34". The Stick-GA2 utilizes an RJ-45 connection.

- Q5. Per Sheet E2.1: Are you going to allow surface mounted EMT between the new L6 fixtures?
- A5. See **Bidders Note 1**, additional **General Information** provided by the Engineer of Record.
- Q6. Per sheet E4.0, detail 1: There appears to be a concrete structure in the middle of the L1 fixture?
- **A6.** There are several beams going from the base of the building up to the roof. The lighting will be between the beams and will illuminate the cove plus shine on the building.
- Q7. Detail (3), Sheet E4.0 is unclear as to what is the intended method of mounting the L2 fixture on the concrete mansard above the balcony. Are we to surface mount the conduit on the exterior side of the mansard? Or are we to run the conduit on the inside of the mansard and drill holes through the concrete mansard, mounting the L2 Fixture on the box? Or is there another application that is expected to be used. Please clarify the L2 mounting application.
- A7. Means and methods are done by the contractor. The conduit should not be visually glaring per the request of the Owner. See <u>Bidders Note 1</u>, additional <u>General Information</u> provided by the Engineer of Record.
- Q8. What is the anticipated start date of the project?
- **A8.** The anticipated start date would be approximately 30 days after the Bid is received, reviewed and approved.
- Q9. Please provide location of IT room.
- A9. See reply to question no. 3.
- Q10. What are the working hours for this project?
- **A10.** The working hours are Monday through Friday from 8:00 am to 5:00 pm. There is no weekend, or holiday work. The successful bidder shall be provided a key for access.
- Q11. Where is the distribution panel located?
- **A11.** The distribution panel is located in the Mechanical Equipment Room as shown on the Sheet **E2.0**.

Revised Bid Item 4 for Bid "A" and Bid "B"

Bid Item 4 (LIGHTING LUMINAIRES, WIRING, and POWER DEVICES) for the Exterior Lighting/Façade Lighting: Payment for all work under Division 16 (LIGHTING LUMINARIES AND WIRING DEVICES) shall be paid for as a lump sum. The contract price paid shall include all work and materials for lighting luminaires and wiring devices per approved drawings and specifications as outlined on sheets E1.0 through E4.0. Sum shall include full compensation for furnishing all labor, materials, tools, equipment, storage, and incidentals involved in the work in this Division including connection to and full coordination of work with including coordination with other trades. Deduction alternates shall be provided on the sheets below. The Owner's representative shall make a final decision based upon the alternates.

Verify location of IT room and bring the required CAT6 cabling to a connection for the lighting controls to the IT room. Coordinate with Manatee County IT department which room they want to use for this purpose. For the bidding process: provide at least 300ft of plenum rated cabling (CAT6), 295ft of conduit (3/4") and strapping, 2 junction boxes, and a connection (RJ-45 per the Stick-GA2 requirements) for the IT run. Exact run has not been determined. Coordinate the exact location with IT prior to starting the project.
