**ITQ No. 24-R084966RB is amended as set forth herein. Responses to questions posed by prospective bidders are provided below. This Addendum is hereby incorporated in and made a part of ITQ No. 24-R084966RB.**

**The deadline to submit all inquiries concerning interpretation, clarification or additional information pertaining to this ITQ was July 9, 2024.**

### QUESTIONS AND RESPONSES:

**Q1. What is the budget allocated for the project?**

R1. The current budget is \$60,000.00.

**Q2. Is the engineering work complete or in progress?**

R2. The boardwalks had engineered drawings and permits when installed. It is our assumption that these repairs involving the replacement of deck boards and toe kicks will not require a new set of plans.

**Q3. Who is responsible for applying for permits?**

R3. We do not believe permits will be required for these repairs.

**Q4. Will there be a mandatory meeting scheduled soon?**

R4. No mandatory meeting.

**Q5. Should we prepare a rough estimate/quote?**

R5. Bids should be final and will be the basis of the P.O. There will be a 10% contingency for unexpected/unforeseen costs to be used with County authorization only.

**Q6. Do we need to visit the site to take exact measurements and photos, and then base the quote on that, including any necessary additional work? Do you agree with this approach?**

R6. Yes. Contractor may visit the site to inspect and take more precise measurements any day sunrise to sunset.

**Q7. I am a general contractor interested in bidding on the Jiggs Landing Repair Project. Can I have a subcontractor verified to meet the experience requirements? Or can the specific boardwalk construction experience requirements be waived?**

R7. No, the Minimum Qualifications are written as the "Bidder" must possess the experience as stated in Exhibit 2, Item No. 3. No, the specific boardwalk construction experience requirements will not be waived.

**Q8. Question regarding item 1, specifically for the removal/replacement of material for Cabin 4, does that include the small deck sitting area between the walkway and the cabin or is it just the walkway itself??**

R8. The replacement is for the walkway to the cabin, not the deck.
