QUESTIONS AND RESPONSES:

- Q1. Was this design explored with any jack and bore contractors to determine if it was definitely buildable as shown prior to issuing the bid package? If so, are there any further details available to show how and where the boring pits might be built to accommodate the large diameter casings and jacking rigs? If not, would open cutting those pipelines be an option?
- R1. An analysis of the constructability was performed for the jack and bore on the west side. The jack and bore was designed at the angle shown and permitted through the FDOT as a diagonal crossing to create more room for the jack and bore pits. The jack and bore east entrance side is 20 feet by 40 feet. Sheet 4 now depicts the approximate locations of the jack and bore pits as well as the dimensions. Open cutting is not currently an option.





BEEN ASSUMED ON THE BASIS OF TYPICAL ANTICIPATED SOIL COVERAGE. CONTRACTOR SHALL NOT RELY ON TH INFORMATION FOR CONSTRUCTION, BUT SHALL BE RESPONSIBLE FOR FIELD LOCATIONS (HORIZONTAL AND VERTICAL OF ALL UTILITIES CROSSING THE PROPOSED PIPELINES. - CONTRACTOR SHALL RESTRAIN PIPE PER RESTRAIN LENGTHS TABLE ON DETAIL SHEET 24
- CONSTRUCTION DEWATERING SHALL BE_CONDUCTED_IN_ACCORDANCE WITH ALL FEDERAL, STATE, AND LOCAL REQUIREMENTS INCLUDING BUT NOT LIMITED TO CHAPTERS 62-621.300 AND 62-620 OF THE FLORIDA ADMINISTRATIVE CODE (FAC)
- EXISTING 2" GAS LINE AND BURIED ELECTRIC TO BE FIELD LOCATED WHERE NECESSARY PRIOR TO CONSTRUCTION
- WHERE LESS THAN 6' MINIMUM SEPARATION IS SHOWN ALL JOINTS SHALL BE RESTRAINED IN ORDER TO MEET FDEP SEPARATION REQUIREMENTS.

<u>GROUNDWATER</u> DEWATERING NOT THE PRESENCE OF GROUNDWATER SHOULD BE ANTICIPATED ON THIS PROJECT. CONTRACTOR'S BID SHALL INCLUDE CONSIDERATION FOR THIS ISSUE.
