Answer: Group A – On-Site Services, Manatee County Animal Services (MCAS)
305 25th Street West, Palmetto, FL 34221.

Group B - On-Site Services at MCAS, Palmetto FL; Awarded Quoters Clinic; deposition location, and the Manatee County Courthouse.

Group C – services to be performed at the primary or secondary awarded veterinary clinics.


Question: Who is responsible for transporting the shelter animals?

Answer: Manatee County shall be responsible for the transportation of the shelter animals.

Note: Group B – Cruelty Examination: The awarded quoter shall be responsible for the complete examination including heartworm and feline leukemia testing only. Every cruelty case is unique and requires specific treatment.

If additional diagnostics / injections / medications / treatments etc. are required the animal shall be transported, by the County, to the Primary or Secondary Awarded Quoter (Group C).

If in the matter of life and death – a Manatee County Officer / Office Manager / or Designee may request additional life saving measures. MCAS shall be responsible for reasonable charges based on the treatment.
