NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract with McCulley Marine Services, Inc. for the provision of Boulders for the Bridge Artificial Reef.

ENABLING/REGULATING AUTHORITY

Manatee County Procurement Ordinance, Sec 2-26.

BACKGROUND/DISCUSSION

Manatee County Parks and Natural Resources received funding to establish an artificial reef off the coast of Manatee County. The awarded firm will supply, transport and deploy limestone boulders or other suitable permitted materials to the permitted Bridge Artificial Reef Site.

The solicitation was advertised on April 26, 2022, on the Manatee County website and Periscope S2G. It was also provided to the Manatee County Chamber of Commerce, the Manasota Black Chamber of Commerce, Gulf Coast Builders Exchange and Gulf Coast Latin Chamber of Commerce for release to its members. Responses were received from the following firms:

2. Sully's LLC - Venice, FL
3. Walter Marine - Orange Beach, AL
