BACKGROUND/DISCUSSION

PROJECT BACKGROUND:

Manatee County is involved in many projects throughout the County. These projects may include but are not limited to widening of roads and intersections, traffic signals, and stormwater drainage. The County additionally acquires fee simple title, easements and other various real property interests for reasons including but not limited to public parks, wetland mitigation and conservation easements. These acquisitions at times will require the services of Land Acquisition and Relocation companies.

The Evaluation Committee convened on 11/3/2014 to provide for the Oral Interview from each firm.

The Evaluation Committee convened on 11/3/2014 to discuss the proposals based on the stated requirements in the RFP, continuing the acquisition process, and determining a recommendation to the County Administrator.

The four firms selected all have all demonstrated the qualifications and capabilities to perform the work in the Scope of Services, resources to meet the needs of Manatee County, extensive knowledge base of all types of acquisition and relocation work required by the County. All the firms have performed a high volume of appraisal work within Manatee County.
