On December 27, 2013 two responses were received; Electro Mechanical South and TAW Technical Field Services, Inc. The response of TAW included an "Amendment to Terms and Conditions Agreement between Manatee County and TAW Technical Field Services, Inc." This amendment "qualifies" the quote response and renders the TAW quote nonresponsive. After an evaluation of the quote responses, Electro Mechanical South as the sole responsive and responsible quote is recommended for the award. 			
SUMMARY	Recommend awarding a blanket purchase order to Electro Mechanical South for a one-year period with four (4) optional renewal years.
