GENERAL CONDITIONS AND SPECIFICATIONS

PURPOSE

It is the intent of Manatee County to hire a contractor to provide the fencing for the new Stage II Landfill Cell. The price quoted must include all expenses necessary to provide the completed project as specified. This will be a lump sum purchase via a Purchase Order to be paid by invoice when the project has been completed to the satisfaction of the County. No progress payments will be made.

CLARIFICATION

It shall be the responsibility of all vendors to request via fax or email any additional clarification of the contents herein. Clarification will be furnished by written addendum from George Earnest of the Purchasing Office. Vendors shall not accept any verbal or telecommunication explanation as authorized clarification of the contents herein.

TAXES

Manatee County is exempt from Federal and State Sales Taxes.

QUALITY GUARANTEE AND REMEDIAL CLAUSE

If any product does not meet specifications or does not produce the results required of the product, the contractor will be required to replace, at no extra cost to the County, any and all products involved.

RESERVED RIGHTS

The County reserves the right to accept or reject any or all quotes, to waive irregularities and technicalities, and to request resubmission. Also, the County reserves the right to accept all or any part of the quote and to increase or decrease quantities or add related items to meet additional or reduced requirements of the County. Any sole response received by the submission date may or not be rejected by the County depending on available competition and current needs of the County. A sole response under these circumstances may be negotiated toward acceptance by the County.

AWARD

Award shall be made to the responsive and responsible quoter having submitted the lowest total price.

TECHNICAL SPECIFICATIONS

- Type Fence: Galvanized Chain-link fence with 2" mesh, commercial grade/9 gauge
- Length/Height: 6660 feet in length / 8 feet tall
- All Corners, Ends and Terminals: 3", 40 gauge
- All "Line" Poles: 2 ½" schedule 40
- All Poles: to be set in concrete
- Top Rail: Install new 1 5/8" schedule 40
- Tension Wire: Install 6660 feet of new seven-gauge bottom tension wire
- Gates: Install thirteen (13) each 4-feet wide/8 feet tall gates, single swing, approximately every 500 feet or at owner's discretion
- Install perimeter fence 2 feet off of established Stage II shell road
