NOTICE OF INTENT TO NEGOTIATE

Notice of Intent to Negotiate with Teledyne Tekmar to provide a Total Organic Carbon (TOC) Analyzer Unit for the Central Laboratory for the Manatee County Utilities Department.

BACKGROUND/DISCUSSION

PROJECT BACKGROUND:

The Manatee County Utilities Central Laboratory has the need to acquire a Total Organic Carbon (TOC) Analyzer unit for the analysis of environmental samples. The objective of this formal, sealed procurement is to replace an existing TOC Analyzer unit that is nearing the end of its lifespan and also to meet the laboratory's growing need to provide inorganic analytical services for the Wastewater Division of the Utilities Department.

SOLICITATIONS:

The RFP was advertised on the Manatee County website, DemandStar, in the Bradenton Herald and the Tempo News and was also provided to the Manatee County Chamber of Commerce for release to its members. One (1) proposal was received.

EVALUATION RESULTS:

The Evaluation Committee (the "Committee") initially convened to review evaluation committee responsibilities and the Florida Sunshine Law as applicable to public meetings and proceeded to review the responsive proposal to the requirements of the RFP. As a result of the discussion, the Committee unanimously voted to commence negotiations with Teledyne Tekmar, Mason, Ohio.

Teledyne Tekmar

Teledyne Tekmar demonstrated exceptional qualifications by means of their proposal. Their submitted proposal was responsive and responsible, meeting all necessary criteria set forth in the RFP. Teledyne Tekmar, a business unit of Teledyne Instruments, Inc., provides high-quality Total Organic Carbon (TOC) and Volatile Organic Compound (VOC) instrumentation. Teledyne Tekmar provided a strong implementation plan and project approach that accompanies the many features of the analyzer unit such as auto-calibration for unattended calibration monitoring, 21 CFR Part 11 functionality, and intelligidilution for automatically diluting a sample back into calibration range.

The Evaluation Committee unanimously determined that Teledyne Tekmar has the experience, capabilities and project approach necessary to provide a Total Organic Carbon Analyzer Unit to the Utility Department's Central Laboratory.

ESTIMATED COST OF SERVICES: The estimated annual expenditure is \$43,000 before negotiation.
