Bidders are hereby notified that this Addendum shall be acknowledged on page 00300-1 of the Bid Form and made a part of the above named bidding and contract documents. Bids submitted without acknowledgement of the Addendum will be considered incomplete.

The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

Bidders Note: The deadline for clarification requests has been extended from June 23, 2010 to June 25, 2010 close of business. When submitting questions please include a reference to the page and / or sheet number of the plans, and / or specification sections when requesting clarification to ensure your specific question is properly addressed. This deadline has been established to maintain fair treatment for all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve. **Questions received after close of business June 25, 2010 shall not be considered.**

The following question is a result of the Information Conference held on June 14, 2010.

Q1: What is the exact load capacity of the Bridge over the spillway?

A1: The exact load capacity of the Bridge over the spillway is unknown. During past maintenance activities, the County has utilized 2 – 25 ton rubber tire cranes to install the stop log. Prospective bidders should consider this as the MAXIMUM allowable load for the bridge structure.

Section 00020 (Page 00020-2) Basis of Award, Article B.03: Qualification of Bidders:

Current Requirement: The License requirement for this project is a General Contractor.

Add the following Requirement:

The General Contractor AND / OR his subcontractor shall have a minimum of five (5) years experience in the installation of Cofferdams and the construction / repair of marine type structures. References and details shall be provided in the Revised Contractor's Questionnaire, Section 00430, Attachment "A" which is made a part of Addendum #1. (3 Total Pages)

In addition to the requirement for normal liability and workers compensation insurance, when the work extends to the water, on a boat or barge, Protection and Indemnity (P&I) coverage is required. In accordance with state regulations for marine contractors, contractor and/or subcontractor must carry Longshoremen's & Harbor Workers' Compensation (33 U.S.C.A. sec. 901) coverage for its employees and Jones Act coverage (46 U.S.C.A. sec. 688) if there are "seamen".


