NOTICE OF INTENT TO AWARD

BACKGROUND/EVALUATION

The County requested proposals from qualified firms for the provision of corrosion and order control services for the County's wastewater collection and treatment system. The County is procuring the services to minimize corrosion effects on wastewater infrastructure and to address nuisance odor issues in the wastewater collection and treatment system.
