Thermal wells in the hydronic piping shall be provided and installed by the quoter.

Crane set up, roof cribbing, structural analysis, roof repair; will be part of the contractor's quote.

Automated Logic will be supplied by the County.

Awarded Contractor and his staff must be cleared through the bailiff daily.
