Authorization to award Invitation for Bid #09-0141DC for the rehabilitation of Satellite Lift Stations Bayshore on the Lakes, Mirror Lakes, and Samoset #1, to the most responsive, responsible vendor meeting specifications, Strickler Bros., Inc., Ft. Myers, Florida, in the amount of \$317,408 (for Bid "B" – 270 contract days); and for subsequent execution of contract and simultaneous dating of performance/payment bonds and acceptance of insurance of certification.

BACKGROUND/DISCUSSION

- This project provides for the rehabilitation to upgrade three satellite lift stations and the addition of an emergency generator installation for each of the locations. The Manatee County Engineering Division designed this project.
- 11/26/08 to 01/27/09 appropriate bid procedures were followed. Bids were solicited via Demand Star to seven hundred forty two (742) prospective bidders and suppliers. Eighty-one (81) firms requested the Bid Document and fourteen (14) bids were received. Estimated start of construction is 03/16/09 with completion within 270 days for an estimated completion date of 12/11/09.
- The funding source for this project is Utility Rates.
