### **QUESTIONS AND RESPONSES:**

**Q1. Under Exhibit 1 Scope of Services, it stated under #14 that e-Builder must be utilized for project records. Will we be responsible for purchasing the software program or will we be working as an agent reporting on your system?**

R1. Awarded vendor will get access from our administrator on a quest account.

**Q2. Based on the available information, it is unknown if the pavement cores have been done at this time, or what the thickness of the cores are. Have they been completed, or are these requested core locations for us to budget and scope out?**

R2. Cores were done on a section of the road. See Lakewood Ranch Blvd Coring Data Report\_MC2\_11.16.23. The scope expanded and no encompasses a rebase of the existing.

**Q3. If the pavement cores have been completed, was there an associated hand auger done with each one of them?**

R3. See Exhibit 4, Lakewood Ranch Blvd Coring Data Report\_MC2\_11.16.23

**Q4. Is there a Geotechnical report with core and subgrade data?**

R4. See Exhibit 4, Lakewood Ranch Blvd Coring Data Report\_MC2\_11.16.23

**Q5. It does not appear that any new roads or shoulders will be constructed that would require a soil boring investigation. Is this true?**

R5. The project limits include only existing roadway section.

**Q6. There does not appear to be any new signage called out on the plans. Will there be new signs that require drilled shaft foundations? I couldn't see those on the plans. Please identify where any signs may be placed so that we can budget soil borings accordingly.**

R6. There will be new single post and multi-post signs. SPM plans are being finalized. No drill shaft work anticipated.

**Q7. The existing bridge appears it will not be altered. No geotechnical services appear to be needed for the existing bridge. Is this true?**

R7. The only bridge work will include refreshing the striping and markings on the deck.

**Q8. This scope appears to be primarily materials testing related for subgrade, base and asphalt materials.**

R8. As this rebase and resurfacing project runs adjacent to multiple residential neighborhoods, vibration monitoring will also be done as precautionary measure.

**Q9. Has the pavement thickness been designed by a civil engineer?**

R9. Th EOR is a Manatee County Staff Engineer.
