ADDENDUM #3

The following items represent clarifications, additions, deletions, revisions and/or modifications to the Contract Documents for the referenced project. This Addendum shall hereinafter be considered full part of the Contract Documents. Receipt of this document must be acknowledged on the bid form.

1) Are we to secure the services of a structural engineer to determine the required depths for sign installation? If so, is there specific information on the weights of the signs as the soil conditions at Coquina beach, (such as a geotechnical report)?

Response: The Contractor will be responsible for the design of the foundation and any required geotechnical engineering reports. Signed and sealed structural plans will be required to be submitted with shop drawings for the foundation design.

2) Do all directional signs have frames?

Response: No.

3) What Thickness and material as to be used for the regulatory signs?

Response: Regulatory signs shall be 0.08 inch minimum thick aluminum plate signs mounted within the frame as depicted in the renderings.

4) The signs that are to be routed, are they raised text or recessed text?

Response: All text is to be recessed.

5) Do we need DOT certification?

Response: This RFQ will not include the construction of the signs specified on the FDOT signage plans.

8) Are we to supply engineering on all signs including the FDOT signs?

Response: This RFQ will not include the construction of the signs specified on the FDOT signage plans.

9) In regards to the rope, we normally will use small nails to secure the rope to the post, is this okay? We also normally butt the end of the rope to each other, trying to hide the end, is this ok?

Response: Both techniques are acceptable. The intent is for the rope accents to match those on the existing gate posts at the site.

10) What part of the signs are painted other than the sign faces in regards to posts and wood backing?

Response: The entry signs will have painted sign faces. The remainder of wood/composite wood components (i.e. frames, backing, etc.) will be unpainted. In the case of wood these components will weather, in the case of composite a color will be selected during the shop drawing process.

11) Entrance signs - We feel that the entrance signs, due to the sizes, would be better if they were two single faced signs mounted back to back with a middle stringer going from one piling to the other instead of one double sided sign that is only attached at each end. The stringer could be wood or aluminum. A lot more support. Please let us know if that will be approved. If not, we need to know a more explicit attachment detail for the sign to the pilings.

Response: The proposed sign fabrication and mounting method seem to be acceptable. It will be the selected contractor's responsibility to provide final shop drawings for review and approval by the engineer and Manatee County prior to fabrication. At that time the contractor will have the opportunity to provide design details which will satisfy the design intent and provide a durable design and materials in accordance with the plans provided.

12) Entrance signs - What is the shell logo made out of?

Response: The shell logo will be made of the same material as the sign itself.

13) Entrance signs - It is unclear on how the signs are fabricated. No side view or detailed instructions leaving a lot of gray area in regards to fabrication. We can do this in either one of two methods and need to know which one is preferred. Option one will be routing out the face of each sign $\frac{12}{2}$ down leaving the logo and lettering raised. The question will arise of how do you want to logo fabricated. The second option is preferred where we route out the whole background, (1/2"), then inset the sign face with the logo and lettering on it. If something ever happens to the sign face, it can be remove and replaced with new without replacing anything else. Should be more durable at the same time.

Response: Please refer to Response #11.

14) Directional and Regulatory signs - Are metal directional signs mounted to a routed out wood back and then installed to the post?

Response: Yes.

15) Directional and Regulatory signs - Do we paint posts?

Response: No. As stated in the written description provided, the posts will be comprised of a recycled composite "wood" product with the color to be approved during the shop drawing process.

16) Rule signs - Waterproof frame around panels is out of what? Can it be PVC (sentra) and is it routed out so the sign face sets inside of it?

Response: The sign face should be inset within the frame. PVC, weather resistant wood, etc. will be acceptable provided the entire sign palette is consistent.

17) Rule signs - What all is painted?

Response: Sign image and test is expected to be printed. Alternate fabrication methods such as painting may be reviewed if the quality of workmanship is in accordance with the details provided.

18) Pictorial - What material are the signs made out of? Are they painted to get the three colors or will there be three separate layers?

Response: Pictorial rule signs are to be routed multi-layered material not painted.

19) Pictorial - What is the bottom copy out of?

Response: Pictorial rule signs are to be routed multi-layered material not painted.

20) Parking lot signs- Again we need to know the fabrication method as I outlined in the Entrance sign questions. Better longevity of the signs if they are two single face signs put together. If only attached at one side, very easy to knock off.

Response: See response #11.

21) Parking lot signs - Are these set in a wood frame work as other signs?

Response: See response #11.

22) Parking lot signs - What are the posts made up of, either wood or standard metal posts?

Response: No metal posts will be used. Wood or composite wood product shall be used for the posts.

23) Parking lot signs - Assume faces are out of metal with reflective background and letters?

Response: Sign faces will be standard Regulatory signs shall be 0.08 inch minimum thick aluminum plate signs with reflective background and letters.

24) Parking lot signs - Breakaway posts?

Response: Breakaway posts should be accounted for in the bid.

25) How many speed limit, no parking, and stop signs are required and are they in a wood framing as all of the others?

Response: Please see the Bid Form provided as a part of this Addendum.

26) Can the sign types be identified by sign type on the renderings?

Response: Sign types have been added to a revised rendering.

27) What is preferred wood product? Cedar is generally acceptable and our typical

Response: Products and materials which will provide a low maintenance, weather resistant, highquality finished product as depicted in the renderings will all be considered. Cedar will be an acceptable product.

28) Can 2" HDU be used as an alternative to the wood for the sign faces?

Response: Yes. Please also refer to Response #11.

29) What is the thickness of the marine rope?

Response: The marine rope shall match the rope used on the existing gate posts at the site.

30) Is a wood frame required for the DOT sign panels as depicted in the renderings?

Response: This RFQ will not include the construction of the signs specified on the FDOT signage plans

31) Are FDOT footers required? If so, which specific locations?

Response: This RFQ will not include the construction of the signs specified on the FDOT signage plans.

32) Are FDOT permits required? If so, which locations?

Response: This RFQ will not include the construction of the signs specified on the FDOT signage plans.

33) Is there a preferred manufacturer for the waterproof frame?

Response: No.

34) Is the pictorial sign routed? If so, what material?

Response: The post is recycled composite 6"x6" with the pictorial images routed in plastic. Three layers of plastic shall be used to achieve the images.

35) Is the post on the pictorial sign square or round (conflict on bid documents)?

Response: As state, 6" x 6" square.

36) Are there any stop/speed limit/no parking signs in this scope of work?

Response: Yes. Please see the Bid Form provided as a part of this Addendum.

37) Sign Type D – single or double sided?

Response: Single.

38) Sign Type D – 3 or 4" posts?

Response: As stated in the written description, the posts for the Directional Signs are 4" square.

39) Are post included in bid price?

Response: All bids for signs include the sign, posts, installation and all incidental items necessary for complete installation.

Question: Will permits be required on any of this work?
