<u>Proposer or their subcontractor must be pre-qualified by the Florida Department of</u> <u>Transportation (FDOT) work classes of (10) Flexible, Paving, (16) Intelligent Transportation</u> <u>Systems, and (39) Traffic Signals.</u>

Submit information and documentation from the issuing agency that confirms Proposer, and/or its subcontractor(s) meet the following:

a. Certified under Section 489.119, Florida Statutes, for a minimum of five years since February 1, 2019, to engage in contracting through a certified or registered general contractor.

<u>No documentation is required. The County will verify the Proposer, or their subcontractor</u> is Certified under Section 489.119, Florida Statutes, for a minimum of five (5) years since February 1, 2019, to engage in contracting through a certified or registered general contractor.

# <u>OR</u>

<u>Provide the work class(es) that the Proposer is prequalified in, along with any</u> <u>subcontractor(s) that are being utilized for other FDOT prequalified work classes. The</u> <u>County will verify the Proposer, or their subcontractor are listed on the FDOT</u> <u>prequalification database.</u>
