## The following questions have been presented by potential bidders:

Question #1: Reference specifications Section 02618, PIPELINE CLEANING, page 114/151, par. 3.02, ACCEPTANCE, sub-par. A-4, please explain how we are to perform an analysis of the condition before and after the cleaning procedure. What exactly is the County looking for with regard to this requirement?

Response #1: The purpose of Section 02618 is to ensure the newly installed pipe line is clean of debris. An analysis of the condition of a new pipeline will not be required.

Question #2: Contractor inquired about the need for ARV's.

Response #2: Per the design, the pipes have been shown installed flat throughout the length of the project to allow for the air to be moved through the pipe. For air scouring to be accomplished and avoid using an ARV's, the pipeline is to be laid with slopes that do not exceed 5%.

Question #3: Contractor inquired about the rehabilitation needs for the existing force main terminus manhole at the intersection of 12th St W and 65th Ave W.

Response #3: The existing force main connection shall be removed from the manhole and the hole shall be repaired with non-shrink grout/cement. No other repairs/rehabilitation shall be required.
