County will evaluate both completion days in determining which completion is in the best interest of the County.

4. **Question:** Clarification whether backfill soil will be provided by the County.

**Response:** The bidder is responsible for purchasing the fill dirt for this project (as specified in the IFB). The Landfill will not be providing trucks or fill material.
