  Committee. However, the firm was ranked overall due to the perception of the Selection Committee of a lesser ability to
  meet County requirements due to organization structure, even with a proposed collection fee 1.2% less than the
  selected firm.

  the collection of municipal traffic fines and moving violations, little in state experience, and their proposed contingency
