Subject Fleet Services Phase 1 Addition

Blair:

The following is our response to contractor questions.

From Mathur Gerdes, RFI 1, dated 12-03-08

Q Can door heights be changed to 7'0" high.

A All doors shall be 7"-2" high.

Q Is the tool room103 to be insulated and receive a drywall finish?

A No, only the two offices receive drywall and insulation on furring.

Q Page A2 elevations show door and window frame heights the same height. Detail 1/A4 shows window height at 6'-8".

A The top of all window and door frames to be 7'-4".

Q Page A4 detail shows existing building wall above new door. What is the new bottom elevation of the wall.

A 7'-4".

Q Page A4 calls for granular fill, is this being called for because no testing is specified?

A No.

Q Page A2 calls for 1/4" glass.

A All glass to be 1" insulated.

Q Page E2 does not call for Romax conduit on the walls, however, the storage room will have exposed conduit on the walls.

A There will be no exposed conduit on the walls.

From Mathur Gerdes, RFI 2, dated 12-05-08

Q Is there a specification for the water cooler?

A Yes, Elkay model EZTL8C, two station.

Q Which faucet is specified?

A Provide the American Standard model 2385.003.

Q Is it OK to cut across the Garage floor to install the sanitary line.

A Cutting across the floor will not be necessary. The existing sanitary tap is approximately 10' east from the southeast corner of the new facility.

From DE Murphy, dated 12-05-08

Q Schedule shows ceiling mount air handlers, drawings show wall mount. Which is preferred?

A Ceiling mount.

Q Are CU1, 2, and 3 in stalled at this time?

A No, only CU1 and associated piping.

Will DE Murphy do core drilling for piping? Q Α Yes.
