The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding and contract documents, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

- 1. Information Conference sign-in sheet is attached.
- 2. The ARVs are to be above ground. Reference Manatee county Public Works Utility Standard Sheet UW-19 dated 3/18/1997, revised 11/99 copy can be purchased from Manatee County Engineering, 941-792-8811 x5039.
- 3. Profile Sheet The invert for the bottom of the 16" water main is at elevation -2.5.
- 4. Manatee County shall provide the Pile Driving Analysis.
- 5. SDR 11 is to elastic and is not acceptable for this project application.

- 6. In reference to road detour: The contractor will secure a Right-of-Way Use Permit from Manatee County. Submission of the maintenance of traffic and road closure schedules will be required.
- 7. Reference Invitation for Bid, Special Provisions (page 100-4, item 5) Professional Engineer is required for submittals in relation to bridge deck design.
- 8. The existing piles will be completely removed by the contractor.
- 9. Plan page B-13 notes that 10 cubic yards of concrete is included in the superstructure pay item for the approach slab sidewalk overlay. The thickness of the superstructure sidewalk is 10" prior to the 4" overlay and is included in the pay item for the Class IV Concrete (Superstructure).
- 10. Plan page B-6 Change reference "...sheet B-15..." to read "...sheet B-10...". There is no page B-15.
