QUESTIONS

1. With regards to the 40 hours onsite configuration requirement (Item #24), is the requirement specifically for the 6500 series and the VSS or for the entire product set on the IFB?

We are asking specifically for a CCNP certified experienced person with 6509 and VSS to be available on an hourly basis in eight (8) hour blocks. The CCNP certified person would have acceptable experience with other devices.

2. Is Smartnet required on the BOM for either the switches or the Nexus NX5010, as it was not requested and wanted to make sure it was purposely omitted?

Smartnet will be added in October/November. Ninety days of support is included with the Cisco equipment.

3. Are we to assume base IOS image for the switches?

All switches are specified with IPB or IPS code by part number.

5. Does the NX5010 require any extra licenses, such as for storage?


No additional feature licenses are needed at this time.
