RFO 19-R070022MG IS AMENDED AS SET FORTH HEREIN. RESPONSES TO QUESTIONS POSED BY PROSPECTIVE BIDDERS ARE PROVIDED BELOW. THIS ADDENDUM IS HEREBY INCORPORATED IN AND MADE A PART OF RFO 19-R070022MG.

QUESTIONS AND RESPONSES:

Q.1. There is no timeframe provided for the term of this quote. Section 6.0 Term on page 6 only states "All services must be delivered on an as needed basis." In addition, the Sample Agreement referenced in Section 6.02, has an Article 3. Agreement Term that has Subsection A. to fill in for dates and number of years, and Subsection B. the County's right to extend language with no specifics.

It is important for prospective quoters to know the length of the Agreement, and what, if any provisions are being provided for annual CPI adjustments, if it is a multi-year contract. It is also recommended and requested that the Article 3. B. extension language be with mutual agreement between the County and Vendor.

R.1. This contract shall be for a period of one year, commencing from the date of issuance of the Blanket Purchase Order, unless extended or terminated as provided in this ITQ document. If not cancelled by the Vendor or the County, this agreement shall be automatically renewed beyond the first twelve (12) month period for four (4) additional twelve (12) month periods not to exceed total contract duration of 60 months providing there are no changes of prices, terms or conditions. Written notice of intention not to renew must be submitted by the successful bidder 90 days prior to the end of a contract period.

Should the Vendor choose not to renew the agreement, the County reserves the right to terminate the Contract with the Vendor and select the next qualified quoter, or re-solicit for those items or issue a new RFQ for all items.

Q.2. The Sample Agreements Article 8. Termination of Agreement is also all at the County's benefit. It is requested that similar termination language be added to the benefit of the Contractor.

R.2. The County has reviewed your request for change to the termination article. This article will remain as stated in the RFO.
