NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract with Ring Power Corporation for the provision of the rental and retainer of a 1250 KW diesel generator for the Special Needs Emergency Shelter during times of a declared disaster.

ENABLING/REGULATING AUTHORITY

Manatee County Procurement Ordinance, Sec 2-26.

BACKGROUND/DISCUSSION

Manatee County is responsible for providing electrical power to the Special Needs Emergency Shelter during times of a declared disaster, usually a hurricane. The retainer of a 1250 KW diesel generator during the hurricane seasons required a competitive solicitation.

The solicitation was advertised on April 20, 2020 on the Manatee County website. It was also provided to the Manatee County Chamber of Commerce and the Manasota Black Chamber of Commerce for release to its members. Responses were received from the following firms:
