##### **1.07 LINE ITEMS AND QUANTITIES**

The County reserves the right to add, delete, and revise Line Items in Attachment F, Quote Form, as required to carry out the intent and purpose of the Agreement.

### **QUESTIONS AND RESPONSES:**

**Q1. In Attachment F, the quote form, you are requesting pricing for "Regular or Handicapped" units. These are 2 different styles and have different pricing. Which type do you require the standard or handicapped accessible units?**

- R1. Both regular and handicapped. Refer to Attachment F, Revised Quote Form, issued with this Addendum No. 1.
- Q2. In Attachment F, the quote form, you request pricing on a “portable unit with trailer”. Is this a standard portable restroom on a tow behind trailer or a fully contained restroom trailer? Do you have a specification for this unit?**
- R2. Both portable restroom unit with trailer and portable restroom trailer. Refer to Attachment F, Revised Quote Form, issued with this Addendum No. 1. Specifications for the units are not available, Bidder shall submit specifications with its Quote.
- Q3. In Exhibit 1 Section L. You state, “Ensure that the rental rates for the portable sanitation units are for the duration of the rental period as quoted”. The contract term is for 3 years and two 1-year options. Does this mean that the prices need to be held for the full 3+ years? Is there a possibility to review pricing between renewals? The current volatility of the consumables and materials may require it.**
- R3. Yes, pricing will be reviewed between renewals.
- Q4. Do you have an estimate of the units that were used in the past year (or previous year due to pandemic) or an estimated quantity of the units and types expected to be needed this coming year?**
- R4. Refer to the ITQ; Attachment F, Quote Form, for the estimated quantity.
