BACKGROUND/EVALUATION

The Work consists of the replacing the Stockade Roof at the Manatee Jail located at 14470 Harlee Road, Palmetto, FL 34221, and shall include all labor, materials, tools, and equipment to install a new weather and watertight High-Performance Thermoplastic Roofing System on a lightweight concrete deck that is dry and structurally sound, as well as all necessary engineering, hoisting, permitting, waste disposal, and incidentals.

The solicitation was advertised on April 7, 2020 on the Manatee County website and Bid Sync. It was also provided to the Manatee County Chamber of Commerce and the Manasota Black Chamber of Commerce for release to their members and in the Bradenton Herald and Tempo News newspapers.
