Greg Gallien of Delta Southern Construction has the following RFI's on the referenced project:

- Wall type definitions on Sheet A-3 appear to be wrong and two definitions have no symbols.
- 2) Four-inch (4") masonry walls on Sheet A-2 and A-3 show to remain. Won't they have to be removed in order to complete plumbing?
- 3) Floor drains and piping appear to conflict with new wall foundations and column pad. Do these get relocated or omitted?
- 4) Vestibule 100 does not appear on finish schedule. Please provide finishes.
- 5) What is the roof deck material under the Standing Seam Roof. Plywood or metal decking?
- 6) The Architect stated in the prebid conference that trusses are to be structural metal and not wood, is this true as the plan does not state.
- 7) Is there a specification for ceramic tile other than size?
- 8) Are lockers, benches, bag racks, etc. by Contractor or Owner as well as installation? If by Contractor, can you specify manufacturer?
- Sheet A-5 calls out LVL beams at steel columns east side of structure. Section 1/A-7 shows concrete beam. Please clarify.
- 10) Window schedule appears to be incomplete and confusing. Shows glazing but notes screen opening. Also window sizes don't match.
- 11) Are windows impact rated?
- 12) Section 7/A-7 shows a box above window. Is this a shutter or what?
- 13) What is soffit material?
- 14) Please clarify steel columns foundations as 4/A-7 isn't consistant with concrete demo removal.
- 15) Is gate adjacent new Concession part of base bid or alternate?
- 16) Sheet A-4 has handicap restroom blowup detail as 2/A-4. 2/A-4 is reflected ceiling plan. Please clarify.
- 17) Please clarify purpose of "fill exposed block on edge". What material shall be used.
- Please specify color and finish of standing seam roof.
- 19) Plans do not call for gutters or downspouts, is this correct?
- 20) Are drywall ceilings to be finished smooth and wall have sand texture as stated on finish schedule?
- 21) Note as on Sheet E-4 references flow and tamper switches for fire risers. Is this a sprinkler system? If so, there are not drawings.
- Please clarify Fire Extinguisher requirements.
