**BACKGROUND/DISCUSSION**

- Award to: Godwin Pumps (Lakeland, FL), Sims Crane (Tampa, FL), Flagler Construction (Tampa, FL), GS Equipment (Tampa, FL), Glade & Grove Supply ( Belle Glade, FL), ASAP Rental (Sarasota, FL), Ring Power (St. Augustine, FL), Gold Coast Equipment (Ocala, FL), Neff Rental (Nokomis, FL), Briggs Equipment (Tampa, FL), Woodruff and Sons Inc. (Bradenton, FL), Grady Land Contracting (Sarasota, FL), United Rentals (Bradenton, FL), and Nortrax (Tampa, FL).
- 2/2/2009 through 5/31/2009 appropriate bid procedures were followed. Notice of bid's availability was broadcast to 230 prospective bidders on DemandStar and MyManatee. Twenty-eight (28) planholders obtained copies of the bid and fifteen (15) bids were received. The heavy equipment rental contract is for use on an as required basis County-wide for a (12) month period with two (2) twelve (12) month renewal periods not to exceed a total contract duration of thirty six (36) months.
- Mike Terrell, Risk Management Department, has purchased LDW insurance through Inland Marine Insurance with coverage up to \$1,000,000.00. "Manatee County will provide Inland Marine Insurance in the coverage's and limits as provided in the Declarations Sheet for leased equipment. A Certificate of Insurance will be issued to Lessor upon request".
- One bid received from Hertz Equipment Rental (Sarasota, FL) was rejected based upon their rejection of Manatee County's Loss Damage Waiver insurance program.
