## **QUESTIONS AND RESPONSES:**

**Q1. Do you have an Engineer's Estimate available?**

R1. The engineer's estimated opinion of cost is \$460,790.00.

**Q2. Can this bid be submitted through Bidsync or only hard copies sent to Manatee County as it states in the Bid Invitation package.**

R2. Refer to A.04 - Submission of Bids, in the IFBC Document.

**Q3. What are the Site Location Addresses?**

R3. Refer to Bid Attachment 3, Plans, for site addresses.

**Q4. Can you provide if each lift station is pumping into a FM, Manhole, or other lift station?**

R4. Refer to Bid Attachment 3, Plans. On each lift station sheet, there is a table "Lift Station Schedule (Existing)". In that table, there is a row labeled "Ex. Force Main Tie". This entry indicates where the subject lift station's force main connects and discharges to; an existing force main (FM), an existing manhole (MH), or an existing lift station (LS).

**Q5. Can you provide if each lift station has an Isolation Valve, and if they are operational?**

R5. Refer to Bid Attachment 3, Plans, if an isolation valve exists, then it is shown on the existing conditions of the lift station sheet. Staff has indicated all isolation valves should be in working order.

Items that are ~~struck through~~ are deleted. Items that are underlined have been added or changed. All other terms and conditions remain as stated in the IFBC.
