NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract with Kimley-Horn and Associates, Inc for the provision of Design Services for G.T. Bray General Development Plan(GDP)/Pickleball Complex Master Plan.

ENABLING/REGULATING AUTHORITY

Manatee County Procurement Ordinance, Sec 2-26.

BACKGROUND/EVALUATION

The supplier will provide all labor, materials, equipment, supplies and travel to develop a GDP for the G.T Bray Park complex and the development of Master Plans for the construction of the pickleball complex portion of the GDP. The services will be provided in phases and will include coordination, field review, data collection, including subsurface utility engineering (SUE) and surveying, public meetings and concept design of the tennis courts, relocation of the basketball courts, proposed and modified parking lots and design with specification and cost estimates for pickleball complex. Information needed for the permitting requirements to include civil, architectural, any required mechanical, electrical, and plumbing services for the County.

The solicitation was advertised on the Manatee County website and DemandStar. It was also provided to the Manatee County Chamber of Commerce and the Manasota Black Chamber of Commerce for release of its members. Responses were received from the following firms:
