The following items are issued to add to, modify, and clarify the quote and contract documents. These items shall have the same force and effect as the original quoting and contract documents, and cost involved shall be included in the quote price. Quotes to be submitted on the specified quote date shall conform to the additions and revisions listed herein.

Quoters Note: Additional questions shall not be accepted at this time as the stated deadline of **November 26, 2012 has lapsed.** This deadline has been established to maintain fair treatment of all potential bidders, while maintaining the expedited nature of the Economic Stimulus that the contracting of this work may achieve. Questions received after this date and time shall not be considered.

Addendum No. 2 is issued in reply to questions received from various Quoters through November 26, 2012. Additional questions shall not be taken at this time.

- Q1. The DOT permit for the bus pad on Manatee Avenue, will the county get that?
- A1. All Bus Stops in FDOT Right of Way have been approved by John Starling from the Department of Transportation, State of Florida. Permits for Bus Stops are not required. Should confirmation by the Contractor be desired of FDOT, Mr. Starling's email address is: john.starling@dot.state.fl.us.
- Q2. Will the Right of Way use permits from Manatee County have to be obtained? Will they charge for the permit if it is required.
- A2. Yes, the Right of Way use permits from Manatee County will have to be obtained. It shall be the Contractor's responsibility to procure the permits.

- Q3. The 4' X 8' Project sign will the two signs be placed on one pad for the entire project or will the signs have to be installed on all pads?
- A3. Only two (2) 4' X 8' signs will be required for the entire project. Signs will be placed at each site while construction is occurring.
- Q4. Who is going to layout the exact location of each pad? Or will it be decided the field at preconstruction?
- A4. The layout for each bus stop pad has been designed by the Engineer of Record with dimensions shown for contractor layout and construction. See plans provided with the Request for Quotation.
- Q5. Are the business ID signs going to be required; we will not block existing access to business.
- A5. For Bus Stops construction, Business ID signs are not required and access must be provided at all times.
- Q6. Do you have a trench drain # they do not have a type D or X?
- A6. A trench drain number is not available.
- Q7. Request asks for a Certified General Contractor, will you accept a licensed concrete contractor?
- A7. The Qualification of the Quoter shall be a Certified General Contractor / and / or a Licensed Concrete Contractor.
