3. Washer # 3 will remain in the Laundry Unit of the Manatee County Detention Facility.
4. All bidders are to bid per the plan set which states 80 lb. capacity for the washers.

C.01 MINIMUM QUALIFICATIONS OF BIDDERS

Bidder shall be an authorized Laundry Equipment Supplier with the ability to obtain contractors and/or subcontractors having a minimum of three year's experience in renovations and installations of similar type facilities. References shall be supplied to the purchasing department with the bid documents. Contractors shall meet all purchasing requirement for bonding, insurance and security access for this facility. All individuals shall be cleared with the County prior to access to the facility.

C.02 BASIS OF AWARD

The maximum funding for this project is \$112,000.00. Award shall be made by the County reserving the right to make award by individual item or group of items (**Bid Option #1**) or (**Bid Option #2**). The determination will be made to the lowest, responsive, responsible bidder meeting the specifications and having the lowest total price or the lowest line item by line item pricing based on the maximum funding of the project. Bid prices shall include costs for furnishing all labor, equipment, and or materials for the completion of the Work in accordance with and in the manner set forth and described in the IFB documents to Owner's satisfaction within the prescribed time.

The contract completion will be for 160 calendar days for either Bid Option # 1 or Bid Option # 2 for the Work as set forth in this IFB.

Only one award shall be made.

NOTE: Inspection of the site is a pre-requisite to be considered for award of this Bid.

In evaluating bids, Owner shall consider the qualifications of the bidders; and if required, may also consider the qualifications of the Subcontractors, suppliers, and other persons and organizations proposed. Owner may also consider the operating costs, maintenance requirements, performance data and guarantees of major items of materials and equipment proposed for incorporation in the Work.

Whenever two or more bids are equal with respect to price, the bid received from a local business shall be given preference in award.

Whenever two or more bids are equal with respect to price, and all other evaluative factors are otherwise equal, including local preference policies, if the company provides documented environmentally preferable "green" products, materials, or supplies, they shall be given preference in award.

Whenever two or more bids which are equal with respect to price are received, and neither of these bids are from a local business, and neither of these bids provides documented "green" products, the award shall be determined by a chance drawing, coin toss, or similar tie-breaking method conducted by the Purchasing Division and open to the public
