NOTICE OF INTENT TO AWARD

Notice of Intent to Award, Invitation for Bid #14-1054CD, Rehabilitation of Sewer Lateral Lines in Collection System #15 on Anna Maria Island, to the lowest, responsive and responsible bidder, BLD Services, LLC of Kenner, LA for a total bid of \$272,225.00 based on a completion time of 60 calendar days.

BACKGROUND/DISCUSSION

- The Work consists of furnishing all labor, materials, equipment and incidentals required to rehabilitate eighty one (81) sewer service laterals and their connection to the main sewer line in Manatee County Utilities' sewer collection system number 15 located on Anna Maria Island. The Work shall consist of, but not limited to, service lateral cleaning and TV inspection, mechanical root or grease removal, installation of one piece resin impregnated cure-in-place pipe (CIPP) liners without excavation, and all required maintenance of traffic. Formal competitive sealed bid procedures were followed resulting in a total of four (4) bidders submitting a sealed bid for consideration:

<u>Hillsborough County, FL</u> Select Environmental Services, Inc.	\$251,210.00
<u>Broward County, FL</u> LMK Pipe Renewal	\$302,945.00
<u>Ohawa, IL</u> Performance Pipelining	\$389,646.00

- The apparent low bidder, Select Environmental Services, Inc., has been deemed non-responsive as they did not meet all of the minimum qualifications listed in the bid documents.
- On August 26, 2014 a memorandum was received from the Utilities Department recommending award to BLD Services, LLC of Kenner, LA for a total bid amount of \$272,225.00 with a 60 calendar day completion time.
- Funding for this project is provided by Utility Rates in the budget account keys 4020019713-534000/5005401-0004 (UM SWR: Lateral Lining AMI).


