SECTION 01150 MEASUREMENT AND PAYMENT

PART 1 GENERAL

1.01 SCOPE

- A. The scope of this section of the Contract Documents is to further define the items included in each Bid Item in the Bid Form section of the Contract Documents. Payment will be made based on the specified items included in the description in this section for each bid item.
- B. All contract prices included in the Bid Form section will be full compensation for all shop drawings, working drawings, labor, materials, tools, equipment, and incidentals necessary to complete the construction as shown on the Drawings and/or as specified in the Contract Documents to be performed under this Contract. Actual quantities of each item bid on a unit price basis will be determined upon completion of the construction in the manner set up for each item in this section of the Specifications. Payment for all items listed in the Bid Form will constitute full compensation for all work shown and/or specified to be performed under this Contract.

1.02 ESTIMATED QUANTITIES

The quantities shown are approximate and are given only as a basis of calculation upon which the award of the Contract is to be made. The County does not assume any responsibility for the final quantities, nor shall the Contractor claim misunderstanding because of such estimate of quantities. Final payment will be made only for satisfactorily completed quantity of each item.

1.03 WORK OUTSIDE AUTHORIZED LIMITS

No payment will be made for work constructed outside the authorized limits of work.

1.04 MEASUREMENT STANDARDS

Unless otherwise specified for the items involved, all measurements of distance shall be taken horizontally or vertically.

1.05 AREA MEASUREMENTS

In the measurement of items to be paid for on the basis of area of finished work, the lengths and/or widths to be used in the calculations shall be the final dimensions measured along the surface of the completed work within the neat lines shown or designated.

1.06 LUMP SUM ITEMS

Where payment for items is shown to be paid for on a lump sum basis, no separate payment will be made for any item of work required to complete the lump sum items. Lump sum contracts shall be complete, tested and fully operable prior to request for final payment. Contractor may be required to provide a break-down of the lump sum

totals.

1.07 UNIT PRICE ITEM

Separate payment will be made for the items of work described herein and listed on the Bid Form. Any related work not specifically listed but required for satisfactory completion of the work shall be considered to be included in the scope of the appropriate listed work items.

No separate payment will be made for the following items and the cost of such work shall be included in the applicable pay items of work. Final payments shall not be requested by the Contractor or made by the County until as-built (record) drawings have been submitted and approved by the County.

- 1. Project signs and photographs.
- 2. Removal, repair, replacement or relocation of all signs, walls, private irrigation systems and related items.
- 3. Rubbish and spoil removal.
- 4. Shop Drawings, Working Drawings.
- 5. Clearing, grubbing, and grading except as hereinafter specified.
- 6. Trench excavation, including necessary pavement removal and rock removal, except as otherwise specified.
- 7. Dewatering and disposal of surplus water.
- 8. Structural fill, backfill, and grading.
- 9. Replacement of unpaved roadways, and shrubbery plots.
- 10. Cleanup & miscellaneous work.
- 11. Foundation and borrow materials, except as hereinafter specified.
- 12. Testing and placing system in operation.
- 13. Any material and equipment required to be installed and utilized for the tests.
- 14. Pipe, structures, pavement replacement, asphalt, and shell driveways and/or appurtenances included within the limits of lump sum work, unless otherwise shown.
- 15. Maintaining the existing quality of service during construction.
- 16. Appurtenant work as required for a complete and operable system.
- 17. Seeding and hydro mulching.

Measurement and payment for this Bid Item shall include full compensation for the required 100 percent (100%) Performance Bond, 100 Percent (100%) Payment Bond, all required insurance for the project and the Contractor's mobilization and demobilization costs as shown in the Bid Form. Mobilization includes, but it not limited to preparation and movement of personnel, equipment, supplies and incidentals such as safety and sanitary supplies/ facilities

Payment for mobilization shall not exceed 10 percent (10%) of the total Contract cost unless the Contractor can prove to the County that his actual mobilization cost exceeds 10 percent (10%).

Payment for all work included in this Bid Item will be made at the applicable Contract unit price for furnishing all labor, materials, and equipment necessary as specified herein or as otherwise necessary for the completion of the Work associated with this Contract. Refer to drawings and specifications.

2A **Pumps 1, 6 and 7 -** Payment for all work included in this Bid Item will be made at the applicable Contract lump sum price for furnishing all labor, materials, and equipment necessary as specified herein or as otherwise necessary for the demolition of the pumps 1 6 and 7 and the completion of the Work associated with this Contract. Refer to drawings and specifications.

Payment for this item shall be each.

All costs for disposal of all items shall be included in the Contractor's Base Bid.

BID ITEM NO. 3- MECHANICAL IMPROVEMENTS

Payment of all work included in this Bid Item will be made at the applicable Contract unit price for furnishing all labor, materials, and equipment necessary for pump replacement, piping, valves, fittings and supports specified herein or as otherwise necessary for the completion of the Work associated with this Contract. Refer to drawings and specifications.

3A **Pumps and Motor Replacement Installation (Pumps 1, 6 and 7)** shall include all labor, materials and equipment necessary for the removal of the existing pump to be replaced and installation of the new axial split case centrifugal pumps as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be each.

3B **36-inch Butterfly Valve** shall include all labor, materials and equipment necessary for the installation of the 36-inch butterfly valve as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be each.

3C **30-inch Flow Control Valve** shall include all labor, materials and equipment necessary for the installation of a 30-inch flow control valve as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be each.

3D **36-inch Ductile Iron Pipe** shall include all labor, materials and equipment necessary for the installation of the 36-inch ductile iron pipe as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be linear feet.

3E **30-inch Ductile Iron Pipe** shall include all labor, materials and equipment necessary for the installation of the 30-inch ductile iron pipe as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be linear feet.

3F **36"** 90 Degree Bend shall include all labor, materials, and equipment necessary for the installation of a 36" 90 Degree Bend as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be each.

3G **36" 45 Degree Bend** shall include all labor, materials, and equipment necessary for the installation of a 36" 45 Degree Bend as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be each.

3H **36**° **Tee** shall include all labor, materials, and equipment necessary for the installation of a 36° Tee as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment of all work included in this Bid Item will be made at the applicable Contract lump sum price for furnishing all plant, labor, materials, and equipment necessary for the refurbishment of the pump station upgrades.

4A **Field Equipment -** Payment of all work included in this Bid Item will be made at the applicable Contract lump sum price for furnishing all plant, labor, materials, and equipment necessary for furnishing the field equipment, including but not limited to start up, testing, training spare parts and other ancillary items necessary as called out on the drawings and per the Contract Documents.

Payment for this item shall be lump sum

4B **Panel Equipment -** Payment of all work included in this Bid Item will be made at the applicable Contract lump sum price for furnishing all plant, labor, materials, and equipment necessary for the panel equipment, including but not limited to start up, testing, training spare parts and other ancillary items necessary as called out on the drawings and per the Contract Documents.

Payment for this item shall be lump sum

4C **Network Modification Cable** - Payment of all work included in this Bid Item will be made at the applicable Contract lump sum price for furnishing all plant, labor, materials, and equipment necessary for the network modification cable, including but not limited to start up, testing, training spare parts and other ancillary items necessary as called out on the drawings and per the Contract Documents.

Payment for this item shall be lump sum

4D **Spare Parts** - Payment of all work included in this Bid Item will be made at the applicable Contract lump sum price for furnishing all plant, labor, materials, and equipment necessary for the furnishing of spare parts and other ancillary items necessary as called out on the drawings and per the Contract Documents.

4E System Integration, Start Up, Testing and Software Implementation -Payment of all work included in this Bid Item will be made at the applicable Contract lump sum price for furnishing all plant, labor, materials, and equipment necessary for the System Integration, Start Up, Testing and Software Implementation and other ancillary items necessary for the complete door installation as called out on the drawings and per the Contract Documents.

5A **Equipment Relocation** shall include all labor, materials, and equipment necessary for the equipment relocation as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be lump sum.

5B **Demolition** shall include all labor, materials, and equipment necessary for site work, demolition, temporary power, and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be lump sum.

5C **Panelboards** shall include all labor, materials, and equipment necessary for the installation of the new panelboards as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be each.

5D Safety disconnects, Junction and Terminal boxes shall include all labor, materials, and equipment necessary for the installation of the junction and terminal boxes. Work will consist of but not limited to placing the junction and/or terminal boxes as called out on the drawings and ancillary items as needed, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be each.

5E **Rigid Conduit** shall include all labor, materials, and equipment necessary for the installation of the rigid conduit as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

5F **Low Voltage Cables** shall include all labor, materials, and equipment necessary for the installation of the low voltage cables as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

5G **Instrumentation Cable** shall include all labor, materials, and equipment necessary for the installation of the instrumentation cable as otherwise called out on the drawings and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be linear foot.

- 5H **Grounding and Bonding** shall include all labor, materials, and equipment necessary for site work, grounding and bonding, and ancillary items as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.
- 5H-1 **Grounding Rods** shall include all labor, materials, and equipment necessary for the installation of grounding rods as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be each.

5H-2 **Bare Copper Cable #8** shall include all labor, materials, and equipment necessary for the installation of bare copper cable #8 as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

Payment for this item shall be linear foot.

5H-3 **Insulated Cable #8** shall include all labor, materials, and equipment necessary for the installation of insulated cable #8 as indicated on the drawings, specified herein or as otherwise necessary for the completion of the Work associated with this Contract.

BID ITEM NO. 6- PERMIT ALLOWANCE

Fees for submitting applications for permits required to complete construction in accordance with the plans and specifications, such as Building Permit, NPDES, etc. The quantity measured for payment shall be the actual receipt-supported permit fees. Payment will be made at the actual cost to the Contractor for the permits required and acquired. Upon completion of the permitting process, the Contractor will submit receipts for permit fees to the County and Engineer.
