# **QUESTIONS AND RESPONSES:**

- Q1. Manatee Palms Lift Station (LS); On page 3 of the plans EXISTING it shows old valve vault to remain. On the PROPOSED it showing new valve vault. Can you please confirmed that the old valve vault is to remain, or should it be removed to make room for new?
- R1. The existing valve vault is to be completely removed and the area backfilled with clean, compacted fill dirt.
- Q2. Rye Rd School LS; On page 6 of drawing it showing new driveway out to Rye rd. After site visit, saw that there is a new driveway from Rye Rd to sidewalk in the

# same location as plans are showing location of new. Can you please clarify what the County is asking for?

R2. A driveway has been installed through another project after this project was released for bid. A whole new driveway may not be required, but some field modification may be warranted. Please complete the bid form as-is.

# Q3. River Wilderness LS; Page 7 of plans show 24 SY of concrete driveway, bid form line 51 is asking for 266cy.

- R3. The bid items for the driveway is #52, SY. The quantity should be 24 SY, not 266 SY. Please note, the bid item for Rye Rd has been revised to match the plans, quantity is now 65 SY.
- Q4. For LS Manatee Palms 2 (RTU 312) plan Sheet 3 specifies aluminum wet well and valve box covers to be rated H-20 instead of the County's standard specification of 300 PSF. Please verify H-20 load rating is required.
- R4. Yes, H-20 is required for both hatches at this lift station.
- Q5. Plan Sheet 3 specifies wet well cover to be 30" x 54" instead of County's standard 36" x 48". Please verify size required.
- R5. The plans have been revised to request a 36"x48".
- Q6. Plan Sheet 10 specifies the control panel and electrical rack installation shall be per 2015 standards which did not include a stainless-steel junction box or DFS-TCU panel, however, both are still listed on the bid form as Item #38 and #39. Please verify their requirement.
- R6. The items have been removed from the bid form.
- Q7. For LS Rye Road School (RTU 355) plans and Bid Form (Item #9) specify a 36" x 48" aluminum wet well cover. Depending on the size of the pumps, this cover may need to be 36" x 60".
- R7. The hatch size has been revised to 36"x60".
- Q8. For LS River Wilderness 3 (TRU 531) plans and Bid Form (Item #9) specify a 36" x 48" aluminum wet well cover. Depending on the size of the pumps, this cover may need to be 36" x 60"
- R8. See response to Q7.

NOTE: Items that are struck through are deleted. Items that are <u>underlined</u> have been added or changed. All other terms and conditions remain as stated in the IFBC.
