#### **BACKGROUND/DISCUSSION**

Manatee County Procurement Division has completed a due diligence review and intends to procure ECO Bionics Biogenerator / Digester Unit Rental and Services from Chemsearch FE without conducting a competitive solicitation process for the following reason(s).

Chemsearch FE has two US Patents for their Bio-generator Automated System and method for growing bacteria and holds the proprietary blend of bacteria strains used in their Free-Flow pellets that are used in the BIO-AMP generator units. Chemsearch FE is the sole proprietor of the patented FREE-FLOW pellets and incubation system. The patented BIO-AMP system which is used to incubate the Bacillus and Pseudomonas strains of bacteria used for Fats, Oils, and Grease (FOG) remediation within the lift stations and downstream collection system.

Chemsearch FE is a sales division of NCH Corporation and is the sole proprietor of the patented FREE-FLOW pellets and incubation system (see attached sole source letter). This is a portion of the patented BIO-AMP system which is used to incubate the Bacillus and Pseudomonas strains of bacteria used for Fats, Oils, and Grease (FOG) remediation within the lift stations and downstream collection system. The BIO-AMP is capable of dosing approximately 30 trillion of these bacteria live into the lift station waste stream every 24 hours, which is another proprietary component of the system.

Chemsearch FE has two US Patents for their Bio Generator-Automated System and Method for Growing Bacteria, US# 7,081,361, and US# 8,093,040. Chemsearch holds a proprietary blend of the strains of bacteria used in their FREE-FLOW pellets which are used withing the BIO-AMP units. Part of what makes this product unique is that it uses the BIO-AMP units to incubate the bacteria so that it introduces the bacteria into the waste stream live, rather than in a sporous state from a powder or bacteria block form. With this process, the bacteria can immediately begin feeding on the FOG within the waste stream breaking it down into a less harmful form.

We began using this product in March of 2013 when NCH Corporation sponsored a year long study on a portion of the NW Bradenton collection system to demonstrate effectiveness of their product. During that time, they dosed their product at four lift stations which prior to treatment needed to be washed down at least twice per month. During the trial, only one station still required to be washed down and it was only three times during the entire trial. Over the course of the study, we saved over \$75,000 in costs between labor, equipment, and odor control chemical costs on just those four stations.
