Award Invitation For Bid (IFB) 17-0395DC, Master Reuse Wet Weather Management Well System Project (North Regional Water Reclamation Facility Deep Injection Wells), to the lowest, responsive, and responsible bidder, Youngquist Brothers, Inc., Ft. Myers, Florida, for a total of \$10,997,777.77 based on a construction completion time of 1,260 calendar days.

Authorize the County Administrator, or his designee, to execute the Agreement and accept and date the Performance and Payment Bonds.

Background Discussion

During wet weather seasons, the supply of reclaimed water exceeds demand and without additional disposal options during these circumstances, unauthorized discharge to surface bodies of water is the only strategy. This project will provide for construction of a Class I deep injection well system for the disposal of the excess reclaimed water and the brine concentrate from the future Reverse Osmosis Facility. The project also includes the construction of three injection wells and associated monitoring wells for transporting waste to the North Regional Water Reclamation Facility.
