We are pleased to provide Manatee County with the following responses to the pre-bid questions for Addendum 1.

Questions received from Bidders - August 15th, 2011 (Information Conference)

Question 1	Are mailboxes are to be furnished and installed? Pay item is for furnishing and installing, there are notes on the plans saying relocate.
Response 1	Mailboxes are to be furnished and installed Notes for mailboxes in plans have been revised to replace, see Plan Sheet 4 & 7-9.
Question 2	There is a note on Sheet 9 saying "End Gravity Wall" is this an extra note that was not removed? We could not find a "Begin Gravity Wall".
Response 2	There is no gravity wall on the project. The note has been removed from Plan Sheet 9.
Question 3	Change bid item for pipe to call out "RCP" instead of "Optional Material".
Response 3	Bid item sheets have been revised to show RCP only for item numbers 430-175-115, 430-175-118, 430-175-124, 430-175-215, 430-175-218, 430-175-224, and 430-175-230.
Question 4	Are there any gas lines located within the project limits?
Response 4	Existing gas lines have been added to the plans, see Plan Sheets 4-10.

Question 5 Does the pay item for concrete sidewalk include 6 x 6 welded wire fabric in accordance with Manatee County standards?

Response 5 In accordance with Manatee County Standards, 6 x 6 welded wire fabric to be included in the cost of concrete sidewalk, see Plan Sheet 2

Question 6 Who will provided signed and sealed MOT plans for the project.

Response 6 Signed and sealed MOT plans are to be provided by the contractor.

Question 7 Will all pipe 48" or less diameter require laser profiling in accordance with Section 430-4.8 of the FDOT 2007 Standard Specifications for Road and Bridge Construction.

Response 7 All pipe 48" or less diameter will require laser profiling in accordance with Section 430-4.8 of the FDOT 2007 Standard Specifications for Road and Bridge Construction.

Questions received from Bidders - (via e-mail)

Question 8 Item 425-11, Drainage Structure-Modify (Existing) 3 ea. The only modifications I see to existing inlets is coring them to accept proposed storm pipe. Is that what this bid item is for?

Response 8 Item 425-11, Drainage Structure-Modify (Existing) is for the coring of existing structures.

Question 9 Note 1 on plan sheet 3 states we are to relocate water meters as directed and the cost to be included in /clearing and grubbing. Can the County please provide a pay item with a quantity to be used on an as needed basis? It is difficult to price something as part of a lump sum pay item that is ambiguous, quantities unknown and may or may not be needed.

Response 9 Item 1080-14, Utility Fixtures (Relocate)(Valve/Meter Box) has been added for the relocation of existing meters, see Plan Sheets 2 &3.
