

Questions from WPCS International Sept. 28/11

1. Question: Spec Section 16108 Miscellaneous Equipment calls for additional disconnect switches, new meter vault and electronic flow meter. Is this additional equipment required for all sites or just specific sites?
Answer: This spec does not apply to this contract, please delete section 16108 entirely.

SECTION 16231 EMERGENCY GENERATOR SET

1. Page 161 of 171, Subpart 2.03 A (3) Enclosure
Delete "...all mounting bolts and screws shall be stainless steel..."
Replace with: "...all **exterior** bolts and screws shall be **316** stainless steel..."
