Response: Bidder is not required to bid both completion days (bid forms). As stated in IFB Section C, "Two schedules for completion of Work shall be considered...Only one award shall be made." County will evaluate both completion days in determining which completion is in the best interest of the County.

4. Question: Clarification whether backfill soil will be provided by the County.

Response: The bidder is responsible for purchasing the fill dirt for this project (as specified in the IFB). The Landfill will not be providing trucks or fill material.
