NOTICE OF INTENT TO AWARD

The Manatee County Procurement Division provides notice of its intent to award a contract to the following firms: 1) Hydradry, Inc.; 2) Unlimited Restoration, Inc.; 3) Above & Beyond Property Restoration LLC; and 4) CBNJR, Inc. DBA Expert Water Removal for the provision of mold and water damage remediation services on an “as needed” basis.

BACKGROUND/DISCUSSION

The Manatee County Property Management Department is responsible for maintaining County facilities. In order to have available at least four contractors to restore buildings damaged by mold and/or water required a competitive solicitation.
