The slack shall be neatly formed into a loop and secured to the camera. A minimum of 10 feet of video cable slack shall be neatly stored at each pull box location within a conduit run. A minimum of 30 feet of slack shall be available for each new video detection cable run.
MFES: Ruggedcom switch model number RSG920P (6GK6092-0PS23-0BA0-Z A05+B05+C02+D02). This switch needs an external power supply model number Ruggedcom RPS 1300 to power the Power- Over-Ethernet (POE) ports.
