The following items are issued to add to, modify, and clarify the bid and contract documents. These items shall have the same force and effect as the original bidding document, and cost involved shall be included in the bid prices. Bids to be submitted on the specified bid date, shall conform to the additions and revisions listed herein.

The deadline of August 4. 2017 to submit all inquiries concerning interpretation, clarification or additional information pertaining to this bid has expired.

The following questions were received during the Non-Mandatory Information Conference and / or via email.

Question 1: Are any of the FPL poles to be relocated? I noted on plan sheet 5, STA: 13+60 an FPL pole looks to be within the limits of the sidewalk. Are we to deflect around the poles or was FPL locating any of these poles?

Response 1: Refer to Sheets 35-39 for utility adjustments.

Question 2: The Utility Plans (Sheet 36 for example) show the asphalt restoration for the utility relocations, if needed. Will we have to mill and overlay the 25 ft, each direction that is usually standard?

Response 2. We do not expect to require milling the full 25 ft in each direction for each of the pavement cuts for utility relocations because this road is due to be fully milled and overlaid after the sidewalk project. Any milling and overlay that may be required shall be at the direction of the Project Representative.

Question 3: Storage Yard. Would the contractor be able to utilize any storage space for materials or park equipment at nights at the County's facility off 30th Avenue and 12th Street?

Response 3: No. There will be no storage / parking allowed on County property. It shall be the contractor's responsibility for safe storage of materials in the right-of-way or for making arrangements to use private property as needed.

Question 4: Maintenance of Traffic: Are we able to close the east bound lane during construction and detour traffic around to 26th Avenue?

Response 4: Contractor must submit a Maintenance of Traffic (MOT) plan for approval. No road closures will be allowed, however, lane closures may be allowed with flaggers during daytime hours only.
