BACKGROUND/DISCUSSION

- ✓ This procurement is to replace the existing Moyno pumps and control panel with Moyno Model 1L4 polymer pumps and controls for the belt filter presses. The existing pumps were installed in 1989 and have exceeded their life expectancy. The control panel is obsolete and replacement parts are no longer available. The belt filter presses are used to effectively dewater the processed sludge.
- ✓ Carl Eric Johnson Inc. has a repair / service facility located in Lakeland, Florida and shall replace, install and commission the new units.
- ✓ Installation 4-6 weeks ARO.
