#### **BACKGROUND/EVALUATION**

At the SWWRF site, Rehabilitate one existing BFP and replace one existing BFP and polymer feed system. Modify and rehabilitate the existing sludge conveyor and truck load-out system. Install cameras to visually monitor BFP's, conveyors, and truck load out from the Administration Building control room. Replace BFP feed pumps and drives and improve sludge transfer pump piping, replacing pumps as needed. Improvements include Supervisory Control and Data Acquisition (SCADA) programming for control and monitoring. Demolish existing equipment as necessary. At the SWWRF & SEWRF replace the electrics, instrumentation and controls on BFP's to facilitate automatic operation.
